WHEN EVERY OTHER DOOR IN AN ANIMAL'S LIFE CLOSES, OURS ARE OPEN. AS AN OPEN ADMISSION SHELTER, WE NEVER TURN AN ANIMAL AWAY. DURING FY18, 6,346 HOMELESS, LOST, ABANDONED AND UNWANTED ANIMALS CAME TO US WHEN THEY HAD NOWHERE ELSE TO TURN. OUR TOTAL INTAKE FOR SMALL MAMMALS INCREASED BY 61%; WE PROVIDED SECOND CHANCES TO 677 RABBITS, RATS, GUINEA PIGS, GERBILS, HAMSTERS AND OTHER SMALL MAMMALS. 1,587 OF THE 2,824 LOST AND STRAY ANIMALS THAT FOUND SAFE HAVEN WITH US WERE REUNITED WITH THEIR OWNERS. WE HAD A 23% SUCCESS RATE IN RETURNING LOST CATS TO THEIR OWNERS, WHICH IS NEARLY FIVE TIMES THE NATIONAL AVERAGE.

AS HUMANE LAW ENFORCEMENT, IT IS OUR ANIMAL PROTECTION & CONTROL TEAM'S DUTY TO ENFORCE LOCAL ORDINANCES AND ASSIST WITH THE ENFORCEMENT OF STATE LAWS TO KEEP ANIMALS AND PEOPLE IN OUR COMMUNITY SAFE. IN FY18, OUR ANIMAL PROTECTION & CONTROL TEAM ASSISTED THE LARIMER COUNTY DEPARTMENT OF HEALTH WITH NEARLY 2,000 RABIES EXPOSURE CASES AND RESPONDED TO 908 ANIMAL BITE CASES. WE ALSO PARTICIPATED IN 1,518 ANIMAL WELFARE CASES. IN TOTAL, WE COMPLETED 18,549 CALLS FOR SERVICE WITH AN AVERAGE RESPONSE TIME OF 19 MINUTES. OUR OFFICERS HELPED SAVE THE LIVES OF 317 PETS LEFT IN HOT CARS; OUR AVERAGE RESPONSE TIME FOR THESE CALLS WAS JUST 13 MINUTES.

EVERY ANIMAL THAT ENTERS OUR SHELTER GETS QUALITY FOOD, VACCINATIONS AND MEDICAL CARE, A CLEAN KENNEL, SOCIALIZATION, WALKS, PLAYTIME, CUDDLES AND TRAINING, ALL DELIVERED WITH LOVE. OUR VETERINARY SERVICES TEAM SAVE LIVES, HEALS SICK ANIMALS, PREVENTS DISEASE AND REDUCES PET OVERPOPULATION. IN FY18, WE PERFORMED 1,224 SPAY OR NEUTER SURGERIES, 290 DENTAL SURGERIES, 66 OTHER SURGERIES AND 168 SURGERIES IN PARTNERSHIP WITH COLORADO STATE UNIVERSITY. WE ALSO ADMINISTERED 8,007 VACCINATIONS. OUR VETERINARY SERVICES TEAM NOW HAS ACCESS TO A STATE-OF-THE-ART CLINIC WITH AN ONSITE X-RAY MACHINE THAT ALLOWED THEM TO COMPLETE DIAGNOSTICS MORE QUICKLY AND CONDUCT EVALUATIONS THAT ARE MORE THOROUGH.
