- Over 1 year, **NOT spayed or neutered** (Seniors are not exempt) \$50.00
- Replacement license tag **with** purchase or renewal of license FREE
- Replacement license tag **without** purchase or renewal of license \$2.50

****Seniors (age 62 and older) who reside within Fort Collins city limits and who qualify for low-income programs, please call 970-416-2350, as you are eligible for a license for each pet at no charge. Any animal over 1 year of age must be altered. These license fees will be paid by the City of Fort Collins. Licenses must be renewed annually**

****Seniors 62 and over in City Limits of Loveland fee is waived – must show proof of residency and DOB. Must be renewed annually.**

****Seniors (age 62 and older) who reside within Unincorporated Larimer County and income qualified for Larimer County services, please call 970-498-7683, as you are eligible for a license at no charge. You must renew on an annual basis.**

****Spayed/neutered pets only.**
